## TOWN OF DUNE ACRES

### 2022 Ecological Cost-Sharing Program

The purpose of the town's cost-share program is to encourage the ecological stewardship of privately-owned property. This includes initial removal of invasive species and ongoing maintenance. In all cases, invasive species removal shall include either total removal of the plant (including roots) or the chemical treatment of cut stems/stumps. In addition, the Grant will fund 50% of the cost to replace an invasive or non-native tree with a native tree. Awards are made on a first-come, first-serve basis. Residents previously receiving an Ecological Cost-Share Program grant are eligible to apply beginning March 1<sup>st</sup>.

1. The following species are considered invasive and non-native for the purpose of this program:

**TREES - grant will fund 50% of removal and/or replacement up to \$500: Norway Maple, Black Locust, Tree of Heaven, non-native Conifers (spruce, sugar pine, and others)**

**WOODY SHRUBS: Burning Bush, Honeysuckle, Autumn Olive, Japanese Barberry**

**VINES: Oriental Bittersweet**

**OTHER: Garlic Mustard, Creeping Charlie, Vinca (Periwinkle)**

2. Cost-Share Applications will be accepted January 1<sup>st</sup> through July 1<sup>st</sup>. A total of \$2,500 in town funds has been appropriated for the 2021 program. Applications will be considered until the appropriation has been exhausted, or up to July 1<sup>st</sup>, whichever comes first.
3. Eligible cost-share expenditures include contracted labor and chemicals, along with tree replacement expense. Residents must demonstrate that all application expenditures are for live invasive species eradication or non-native tree replacement. Other landscape work is not program-eligible.
4. Residents should first select a qualified contractor to prepare a quote for work. The written quote will then be submitted to the office of the Clerk-Treasurer with the application. Contractors providing services under this cost-share program must meet minimum qualifying requirements:
  - a. Town-registered
  - b. General knowledge of ecological restoration best practice
  - c. Hold herbicide application certification
5. Residents will be notified in writing regarding their program award. Cost-share distribution from the town will be issued following completion of all work, inspection of work by town officials, and proof of payment to the contractor. Completion paperwork must be received by the Town prior to December 1, 2022.
